



## **Canada Study Visa Document Checklist (First Entry)**

- Digital ID Photo (35\*45 mm, 70% face, white background)
- Valid passport full scan (1 year)
- Previous visa history (previous passport ID page, sign page and visa stamp pages scan)
- Family registration certificate
- Birth certificate
- Last qualification certificate
- Proof of funds/GIC
- Letter of Acceptance from the DLI registered inst.
- 1-year tuition deposit evidence
- Police character certificate
- Sources of income/income tax returns of sponsor(s) -- not compulsory but recommended
- Statement of purpose/letter of motivation
- IELTS: 6.0 bands each and overall
- e-medical letter
- Polio certificate and covid-test after visa approval

## **Following steps are included after getting the offer letter:**

### **1) Fee Payment:**

- Fees can be paid from anywhere also can be transferred directly from bank account if the university doesn't involve any third party.
- Fee paid through a third party is mainly FlyWire or any other service like this one.
- The fee submission process of FlyWire is proceeded through money exchange.
- Swift receipt is provided by the money exchange in 2 to 3 days. The receipt is sent to the university after which they provide the final Letter of Acceptance.



## 2) After Receiving the Final Acceptance Letter:

- Block account known as Guaranteed Investment Certificate (GIC) will be created. The confirmation of block account is received in 2 to 3 days after which we have only 24 hours to initiate the payment.
- The block account we create for student is mostly in Canadian Imperial Bank Of Commerce (CIBC)
  - For GIC either the student should have his/her own local personal bank account or a joint account with their parents. Any other kind of account is not accepted.
  - The details provided by the students i.e. mainly Address, Name etc. should be the same in the letter of Acceptance, GIC and the bank account in Pakistan.
  - A total of \$10,000.00 CAD are needed in the GIC account which is to be transferred from the student's bank account in USD so it is student's responsibility to make sure that his/her selected bank allows PKR to USD transfer.
  - In case the bank does not allow transfer from the student's normal bank account, he/she should create a Foreign Currency (FC) account.
  - After the payment is confirmed, we will receive the letter/certificate for the confirmation of student's CIBC account.

## 3) On the other hand, we apply for the student's medical as it is needed upfront in SDS.

- We just have to send an email for the appointment which is mainly set in the next week.
- The students will have attend it with all the required documents.
- The fee for medical is 21,600 PKR, paid in cash on the day of appointment.

**4) Following financial documents are required:**

- Affidavit of financial support is needed for which we provide the samples.
- If the student's sponsor is a tax filer then tax returns documents and NTN of business are required. (Recommended but not mandatory)
- Student's sponsor Bank Statement. (Recommended but not mandatory)
